Notice of Open Market Repurchase of Treasury Stock

COMSYS HOLDINGS Corporation has announced the status of its open market repurchase of treasury stock pursuant to Article 156 of Japan's Company Law, which is applicable in accordance with the provision of Article 165, Paragraph 3, as described below.
