3. Reason for change of trade name

Hokuriku Denwa Kouji Co., Ltd., a core company of the Group, was founded in November 1949 and has operated under its current trade name, “Hokuriku Denwa Kouji Co., Ltd.,” since 1954, supporting the social infrastructure of the Hokuriku region through the development and maintenance of telecommunications and information infrastructure. In recent years, as the social environment has changed and ICT and digital technologies have advanced, the challenges faced by customers have become increasingly diverse and sophisticated. Based on the technological capabilities and trust that the Company has cultivated over the years, the trade name will be changed to “HOKUWANEX Co., Ltd.” in order to respond to the expansion of business domains and diversification of value provided, and to achieve further enhancement of corporate value and growth.

The Group’s reportable segments consist of group-based segments centered on the respective core operating companies.
